Shared Mobility Program Update

Metro Transit's Shared Mobility Program Manager Meredith Klekotka provided a program update for council members at Monday's Metropolitan Council Transportation Committee meeting. The presentation outlined the seven goals identified in the 2019 Shared Mobility Strategy report. Some of these include the implementation of a microtransit pilot, investment in mobility hubs, and educational efforts. The Shared Mobility Program has funded their efforts using a mix of sources including Metro Transit's discretionary budget, competitive grants, and federal transportation dollars.

As part of the presentation, Klekotka described an upcoming microtransit pilot coming to North Minneapolis this Fall. The pilot will use an app to provide riders with trips to their destination on smaller, multi-passenger vehicles. Fares will be the same as bus fare on any other Metro Transit bus with normal transfer rules applying. Metro Transit's marketing campaign for the microtransit pilot will kick off two weeks before service begins.

The remainder of the presentation was dedicated to mobility hubs. Specifically, Klekotka introduced committee members to the Mobility Hub Planning and Implementation Guidebook. The guidebook identifies existing mobility hubs throughout the region and provides resources, strategies, and other tips for interested public agencies or community organizations. 2025 Water Resources Policy Plan Update

Metropolitan Council staff provided an update on the ongoing Regional Water Planning efforts being undertaken by the Council in conjunction with regional stakeholders serving on the Water Resources Policy Plan Advisory Group. Several cities are participating on this advisory group, which has met three times since Fall 2021. Based on initial feedback and in reaction to emerging issues, council staff are conducting research and developing white papers to share with stakeholders and Council Members. A heavy emphasis has been placed on capturing local perspectives in the development of the draft 2050 Water Resources Policy Plan and Metro Cities encourages cities to share their thoughts as that work continues. HomeHelpMN Application Deadline Extended to August 17

The HomeHelpMN application deadline has been extended until August 17 at 5:00 pm to allow more households the opportunity to submit an application. Minnesota Housing announced the decision for Minnesotans who have fallen behind on their mortgage or other housing-related expenses due to the pandemic. DEED Awards \$4 Million in Contamination Cleanup Grants

Four metropolitan region cities will receive state funds to help clean up contaminated sites for redevelopment. DEED's Contamination Cleanup Grants cover up to 75% of the costs of removing contamination at approved polluted sites. The remaining costs are covered by cities and counties, other units of local government, and private landowners and developers.

Funds for redevelopment projects in Golden Valley, Hopkins, Minneapolis, Saint Louis Park, and Saint Paul were awarded this round. Metro Cities supports state funding for the contamination cleanup program as well as the Redevelopment Grant and Demolition Loan Program, which helps cities with other redevelopment-related costs. The application deadline for the current round of that program is August 1. More information on the awards can be <u>found here</u>.
