# **Private Inflow & Infiltration Grant Task Force**

Metropolitan Council staff presented information on private property inflow and infiltration at this week's Environment Committee meeting. Recent changes to Minnesota law allows the Metropolitan Council to establish a private property inflow and infiltration prevention program and make loans or grants to private property owners.

The Council will convene a task force to develop program guidelines for grants. The proposed task force will include municipal employees (engineers, public works, finance, and building officials), city administrators, and Metro Cities staff. The task force is anticipated to begin in November and will run until April 2023. Metro Cities will provide information and updates as recommendations for a grant program are developed and solicit input from cities on program criteria and requirements. ## 2023-2028 Capital Programs for Transportation and MCES

Information on the 2023-2028 capital programs for transportation and environmental services was presented to members during this week's Metropolitan Council committee meetings. See below for highlights and links to presentation materials.

#### Transportation Division Proposed 2023-2028 Transit Capital Program

The proposed 2023-2028 CIP contains \$3.021 billion in planned investments. This includes both Green Line and Blue Line extension projects. Without the LRT Transitway projects the total is \$1.413 billion. The CIP covers the entire regional transit system including Metro Transit, Metropolitan Transportation Services, and suburban transit providers.

The CIP focuses on several key goals:

- Expanding the transit network.
- Creating faster and more reliable service.
- Improving the customer experience.
- Improving existing facilities.
- Enhancing safety and security.
- Investing in the workplace (employee spaces and facilities).
- Sustainable investment, including zero emission buses.

The CIP will be officially before the Metropolitan Council at their October 12<sup>th</sup> meeting. Following a public comment period, the Capital Program will be considered for full adoption on December 14<sup>th</sup>, 2022. Click <u>HERE</u> to view the CIP presentation materials.

#### Environmental Services (MCES) 2023-2028 Capital Program

The proposed 2023 capital program includes \$1.263 billion as a part of the Authorized Capital Program (ACP) and \$778 million coming from the Capital Improvement Program (CIP) for a total of \$2.041 billion.

The three objectives cited in the Capital Program materials include:

- Preserve Assets: Rehabilitate and replace assets to preserve value and performance.
- Meet Capacity Needs: Expand system capacity through plant expansions and interceptor extensions or improvements.
- Improve Quality: Improve quality of service by responding to more stringent regulations, reusing wastewater, increasing system reliability, and conserving and generating energy.

## 2023-2026 Transportation Improvement Program Adopted

The Metropolitan Council adopted the <u>2023-2026 Transportation Improvement Program</u> (TIP) on Wednesday following the 45-day public comment period and recommendation by the Transportation Advisory Board (TAB) and Transportation Committee. The TIP lists funded transportation projects within the metropolitan planning area. The 2023-2026 TIP contains approximately \$5.6 billion in highway, freight, transit, bicycle, and pedestrian projects. About 56% of total spending is from federal sources with 10% from state sources, and 34% from local/other sources. The TIP includes \$2.8 billion for transit, \$2.4 billion for highways and roads, \$120 million for non-motorized transportation, and \$386 million for all other projects.
